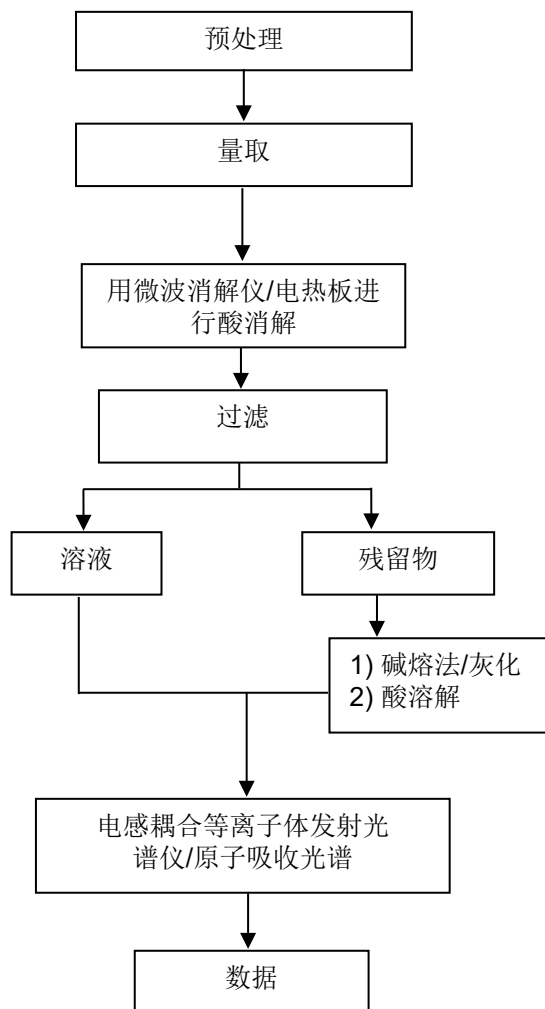

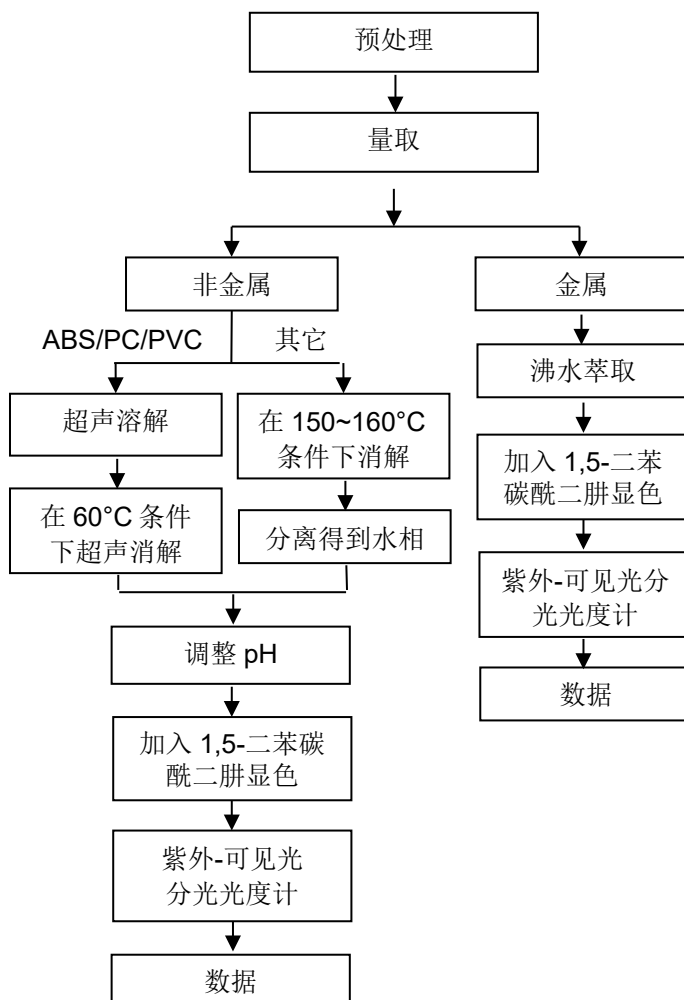

### 元素检测流程图

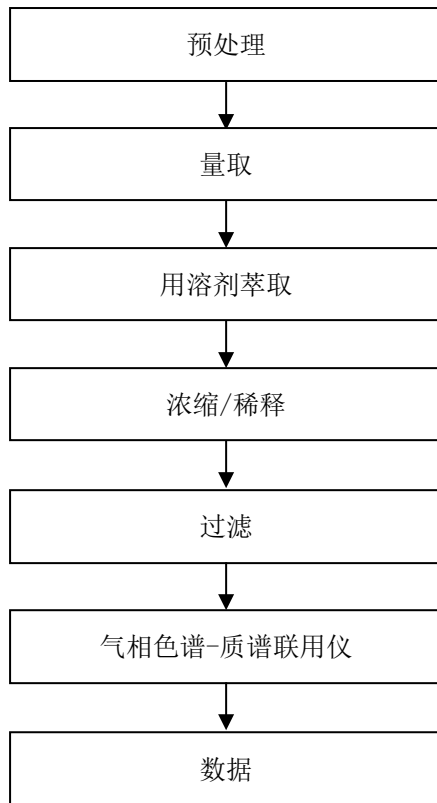
样品按照下述流程被完全消解

### PBB/PBDE/Phthalates 检测流程图





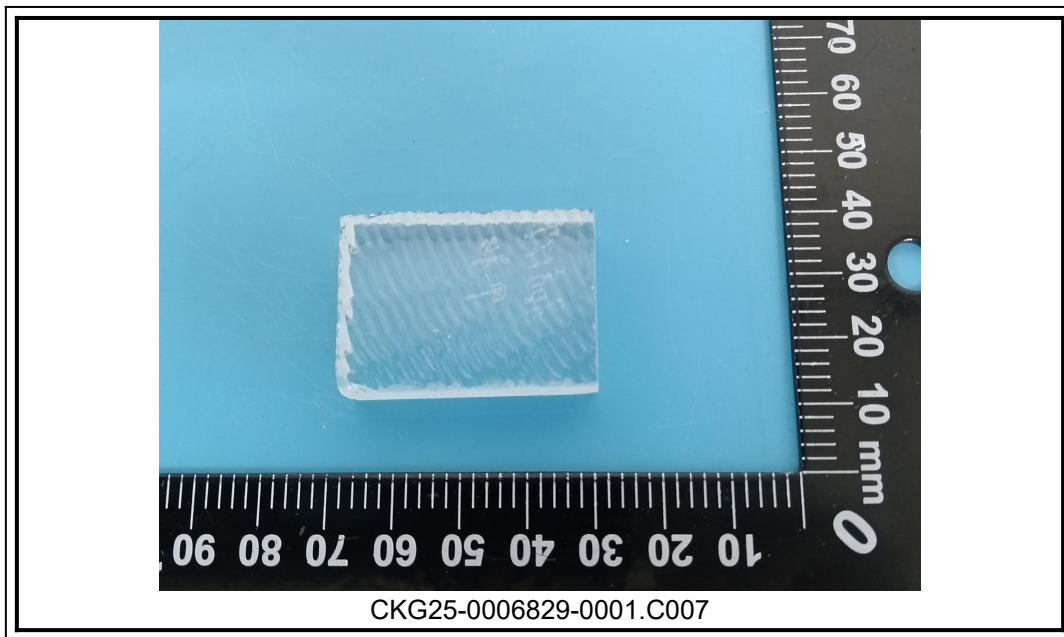
