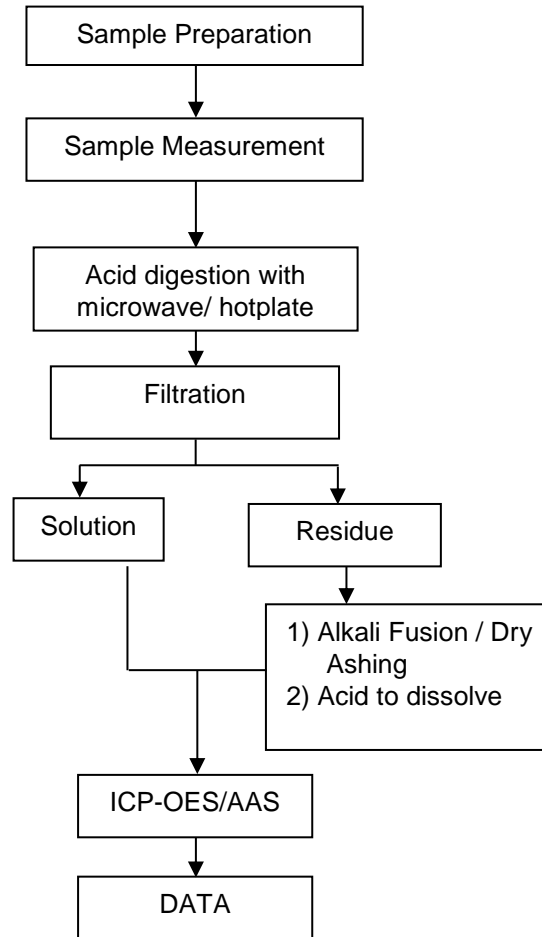

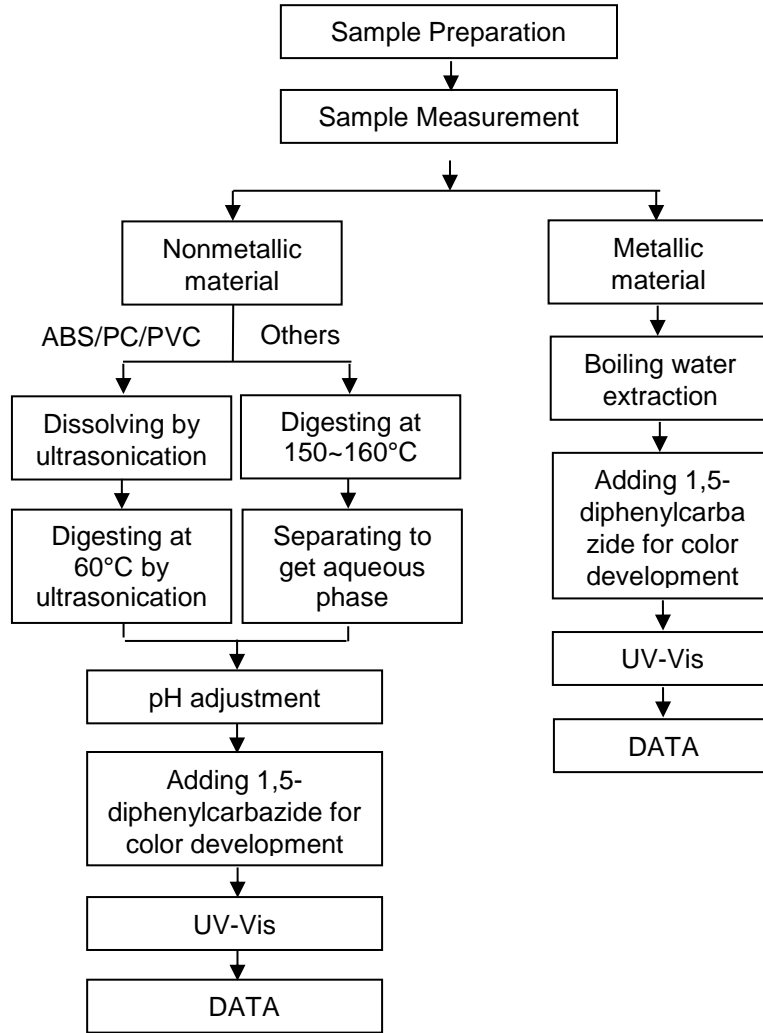
**Elements Testing Flow Chart**

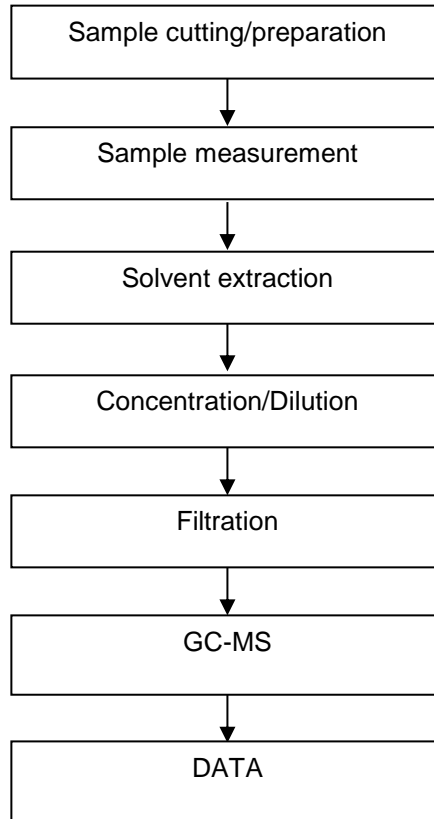
**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**
